II. Facility 1415 Hyde Park Ave

A. New Site (B Street)

Phasing suggested to free up space on 1415 and get 1424 moving first, as 1424 is a much smaller scale project now.

B. 1415 Hyde Park Ave

1415: Next 5-10 year needs for potential repairs, capital plan
